# **DSHS** Breast and Cervical Cancer Services

Every October a sea of pink can be found to promote Breast Cancer Awareness month. Countless lives have been lost to this disease, but may have been saved because of early detection and treatment. Texas A&M AgriLife Extension supports the efforts to get your recommended screenings and mammograms. The following information provided by the Texas Department of State Health Services (DSHS) Breast and Cervical Cancer Services explains how to help women who are uninsured get the services they need to be proactive in the fight against breast cancer.

The Texas Breast and Cervical Cancer Services program helps fund clinic sites across the state to provide quality, low-cost, and accessible breast and cervical cancer screening and diagnostic services to women. These services help women receive regular screening, which is the best method to prevent and detect breast or cervical cancer in its earliest stages increasing a women's chance of survival.

You may qualify for free or low-cost breast or cervical cancer screening and diagnostic services if you:

- 1. Live in Texas, and
- 2. Do not have health insurance; and
- 3. Are age 18 or over; and
- 4. Have income up to 200% of the Federal Poverty Level (see table below)

You may qualify for Medicaid for Breast and Cervical Cancer (MBCC) if you:

- 1. Have been diagnosed with breast or cervical cancer; and
- 2. Need treatment for a breast or cervical cancer; and
- 3. Live in Texas; and
- 4. Are a U.S. citizen or eligible immigrant; and
- 5. Are age 18-64 years; **and**
- 6. Do not have health insurance; and
- 7. Have income up to 200% of the Federal Poverty Level (see table below)

You may qualify for free or low-cost breast and cervical cancer screening and diagnostic services if you meet the general eligibility criteria above and are:

## **Breast Cancer Screening Services:**

- Age 40-64 years
- Over age 64 years and not eligible for Medicare

## **Breast Cancer Diagnostic Services:**

- Age 18-64 years
- Over age 64 years and not eligible for Medicare

#### **Cervical Cancer Screening Services:**

- Age 21-64 years
- Over age 64 years with and has had cervical cancer or moderate-to-severe cervical dysplasia and not eligible for Medicare

#### **Cervical Cancer Diagnostic Services:**

- Age 18-64 years
- Over age 64 years and not eligible for Medicare

### High priority populations most at risk for developing breast or cervical cancer:

Breast cancer screening: Ages 50-64 years Cervical cancer screening: Ages 21-64 years
